The Independent Police Complaints Commission (IPCC) became operational on 1 April 2004. It is a **Non-Departmental Public Body (NDPB)**, funded by the Home Office, **but by law, entirely independent of the police, interest groups and political parties and whose decisions on cases are free from government involvement.**

They say ... We have a legal duty to oversee the whole of the police complaints system, created by the Police Reform Act 2002, our aim is to transform the way in which complaints against the police are handled.

Who carried out the investigation and what was their background and experience?

Senior Investigator John Cummins led the investigation. **He retired from Cambridgeshire Police in 2004 as the Detective Superintendent in charge of the Professional Standards Department.** He was formerly a Senior Investigating Officer and had completed 30 years police service.

John Cummins was supported by Steve Reynolds, **a Detective Chief Superintendent, and formerly the Head of Essex CID and an experienced SIO.** He was seconded to assist the Stockwell investigation prior to retiring from Essex Police on 31 August 2005 following 31 years service. He now works for the IPCC as a Senior Investigator.

John Cummins and Steve Reynolds worked with a team from a variety of police and non-police backgrounds.

Nick Hardwick, IPCC Commissioner and Chair of the Commission, oversaw the investigation. History and biography at ...
