Parole Board figures just released; show that of the number of prisoners given life sentences in the year 2000,125 were given early release from that sentence. Last year 351 were given their freedom, with many offenders going on to commit further serious crime.

We have a major problem in this country, more serious crime is being committed yet, we cannot find prison accommodation for the offenders, so instead of implementing a prison building plan the Home Office goes for the easy option, minimum sentences and community service. Fair justice would have it that more prisons would end the overcrowding, and give a chance at making prison work effectively, and that is obviously the rehabilitation of the offender to re-enter into the community. This is justice for the public and likewise for those offenders who do have a desire to be law abiding but at the moment cannot kick his or her drug or alcohol problem because of the pressure of overcrowding in our prisons. Training and rehabilitation has to be a condition for release back into our communities.

Sadly the respect that one used to have for our fellow humans has evaporated over the years. The amount of violence that occurs in today's society no longer has the same affect as one used to feel, conditioning and acceptance of violent behaviour has become the norm, something that would never of happened in the past.

Anti social behaviour has taken over, and it has led to many needless deaths. The local tragic and brutal killing of teenager Ben Bellamy has affected many Swansea citizens. This is being repeated nationwide, knife crime has taken many lives, gang culture is growing and they are congregating in our communities terrorising people.

We are told that this country is on terrorist alert; our communities will have to be prepared for a diversion of Police resources because we have allowed some unchecked immigrants into the UK. This has increased the burden onto our police at the behest of local community policing. Nationwide the public agrees that the police force is seriously undermanned. Local community police stations are closing and police on our streets are a rare sight.

There is no doubt that the police force is in need of massive reform, not in the fiasco of amalgamation, but internal affairs needs an overhaul in the amount of paperwork that arresting officers are required to complete which takes them off our streets for hours at a time. A mass recruitment drive for more officers should be underway from the Home Office in order to give the vital support to current serving officers desperately need.
