This **disturbing and gratuitous** program glorified a family of travelers who lived by violence and theft and preyed on families and businesses across southern England.

The labour government have empowered travelers to abuse and flout a whole range of planning regulations and blight whole communities right across the UK. The 'architect' of these policies was **apparently** that great political intellect **John Prescott**. Their objective in so doing is probably a part of their class warfare against anyone with high standards of behaviour and who achieved success and ownership of land or property by hard work. ACC Ian Shannon's Blogs on the subject ... *The second issue was difficult and intermittent but was causing **distress for local residents and businesses**. The latter problem has arisen from a **visiting group of travellers** who have moved onto **the Antelope Industrial Estate**. This area is well kept and it is clear that **the owners and businesses present are proud of the site and of their contribution to the local economy**. I should say that they are **usually** proud of the condition of the estate but in the **past few months** travellers have camped on the site, this need not necessarily be a problem but **sadly** it has been in this instance. I invite you to look at the attached photographs of the estate, which do not actually do justice to the disgraceful conditions that have developed, **this includes rubbish and faeces strewn over the estate and trees and shrubs that have been cut down elsewhere and dumped on the estate**. In addition **significant criminal damage has been done to some of the buildings on the site**. I must **emphasise** that we can not - at least yet - prove who has caused this damage but the reality is that tensions are palpable and businesses are suffering and local residents are not happy.*

*It is clear that **there are simply insufficient permanent sites for travellers in North Wales**, this has been highlighted by the **Commission for Racial Equality (CRE)** and **the CRE are simply right**. This can lead to travellers moving from place to place, or indeed being moved, as if they were the unfortunate pawns in an unhelpful and unwanted game of pass the parcel. This is good for nobody and can lead to tension and rancour. **North Wales Police will continue to lobby** for greater*

provision of sites for travellers, not only is it the right thing to do but we are also often the piggy in the middle trying to defuse tensions between local residents and travellers.

*We will also continue to work with the CRE to **stamp out iniquities** such as ‘no travellers’ notices in pubs or shops - such signs can really only be described as **racist**.*
